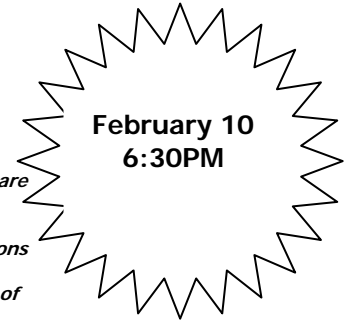


## AGENDA
